General Conditions

1. Return Period

Products purchased through our store can be returned within 14 calendar days from the date of delivery.

2. Condition of Returned Products

Returned items must be in their original condition, unused, undamaged, and in complete original packaging with all accompanying documents (instructions, warranty, etc.).

3. Return Approval

Returns are only possible after prior approval from our customer support. Please contact us via email at **sales@ipf-industry.com** for instructions on returning the product.

Custom and Special Orders

1. Non-returnable Items

Consumables made to order or customized according to customer specifications cannot be returned unless defective or damaged upon delivery.

2. Seller's Rights

The seller reserves the right to refuse the return of products that have been modified or tailored to individual customer specifications.

Return Procedure

1. Return Request

Customers must submit a return request to our customer support at **sales@ipf-industry.com**. Upon approval of the return, customers must send the product back within 7 days from the approval date. Return shipping costs are the responsibility of the customer unless the return is due to our error (e.g., defective product).

2. Return Process

Once we receive the returned item and inspect its condition, we will confirm receipt via email. If the return is approved, a return will be processed and returned to your payment method within 14 working days.

3. Adjustments for Damaged Returns

If the returned item is incomplete or damaged due to the customer's fault, the return amount will be adjusted accordingly.

Claims for Defective Goods

1. Reporting Defects

If you receive a defective product, please contact us immediately with a detailed description of the defect, including photographs.

2. Resolution of Claims

Defective products will be repaired, replaced, or refunded, including shipping costs, within 30 days of claim submission.

Exclusions from Refunds

1. Used Items

Items that have been used or show signs of wear cannot be returned unless the reason for the return is a defect in the product.

2. Consumable Items

Consumable items that are prone to quick wear (e.g., electrodes, nozzles, abrasive discs, etc.) cannot be returned after use.

Changes to This Return Policy

We reserve the right, at our sole discretion, to modify or replace this Return Policy at any time. If a revision is material, we will make reasonable efforts to provide at least 30 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.
